

MINUTES: UBLY COMMUNITY SCHOOLS BOARD OF EDUCATION MEETING  
August 14, 2023

The Ugly Community Schools Board of Education met in regular session on Monday evening, August 14, 2023, at 7:00 p.m. in the Library.
